

Town of Mercer Meeting Minutes

June 20, 2019 (approved).

Call to order

Chairman John Sendra called meeting to order at 5:30pm at the Haines Bldg.

Roll call

Town Clerk Amber Thompson conducted a roll call. The following persons were present: Supervisor Chuck Schroepfer, Supervisor Eric Snow, Chairman John Sendra, Supervisor Opal Roberts, Supervisor Mike Lambert. Absent were Treasurer Lin Miller and Attorney Fritz Schellgell.

Approval of minutes from last meeting:

Motion to accept with corrections the prior minutes made by Supervisor Opal Roberts, seconded by Supervisor Chuck Schroepfer. Carried.

Public Comment: Town Foreman Jake Saarnio discussed the Martha Lake Road work where while digging 13 feet away from a marked gas line one of the town operators hit a line. They called in to emergency services and We Energies and USIC Marking were on scene. They stated the town crew were not at fault.
